

Refer A Friend – T&C

1. Program Overview:

- a. The Refer-a-Friend Program (the "Program") allows eligible participants to refer friends or acquaintances ("Referred Friends") to Trazé and earn rewards as defined herein. The Program will start 9th Nov. 2023.

2. Eligibility:

- a. Only clients from SSA region are eligible for this program
- b. Here are the eligible countries: South Africa, Ghana, Kenya, Nigeria
- c. You need to have a registered account with Trazé
- d. Your account should be fully verified
- e. The user referred within the framework of this program shall not be categorized as a client of IB
- f. Referred friends must not be current customers of Trazé.
- g. To refer a friend participants will receive a unique referral code or link from Trazé
 - i. To receive your unique link, you need to provide your account information [here](#) and you will receive the link via email.
 - ii. Participants can share their referral link with Referred Friends.

3. Referral Process:

- a. To get a successful referral, referred friends must meet these criteria:
 - i. Referred friends must use the provided link when registering with Trazé.
 - ii. Referred friends must make their first deposit
 - iii. Referred friend must have minimum trading volume of 2 lot
 - 1. Trading stocks will not be counted in the trading volume calculations
 - 2. Orders that are opened less than 2 minutes will not be counted in the calculation
- b. Trazé will keep participants informed about the status of their referrals, reward eligibility, and any changes to the Program through email communication
- c. Successful referrals will be verified by Trazé based on provided criteria
- d. Rewards will be distributed to eligible Referrer and referee within 48 hours from the date of the criteria been met.

4. Rewards:

- a. Upon a successful referral:
 - i. Referrer will receive \$40 withdrawable cash in their primary account
 - ii. Referee will receive 100% deposit bonus (trading credit) in the chosen account. This 100% deposit bonus will follow this [T&C](#)

- b. The nature and the amount of rewards are subject to change at the discretion of Traze.
- c. The reward will only be assigned to the first 100 successful referrals.

5. Privacy & Compliance:

- a. This Program is subject to all applicable laws and regulations. Participants must comply with all legal requirements.
- b. Traze will collect and process personal information in accordance with our Privacy Policy. By participating in the Program, you consent to such data processing.
- c. Traze reserves the right to disqualify participants engaging in fraudulent activity, including, but not limited to, referring fake or ineligible Referred Friends.
- d. Any fraudulent activity may result in the forfeiture of rewards and potential legal action.
- e. Traze is not responsible for any errors, omissions, or technical malfunctions that may prevent participants from receiving rewards.
- f. Traze shall not be liable for any indirect, special, or consequential damages arising from participation in the Program.
