

Traze 100% Deposit Bonus

Terms and Conditions

1. Eligibility

- 1.1. The Deposit Bonus Promotion is open to individuals who reside in SSA region. Here are the eligible countries: South Africa, Ghana, Kenya, Nigeria
- 1.2. Participants must be of legal age (18 years or older) and have the legal capacity to register and participate in the promotion.
- 1.3. Employees, affiliates, and immediate family members of the company organizing this promotion are not eligible to participate.

2. Mechanism

- 2.1. The promotion will commence from September to December of 2023 and might be extended upon the announcement.
- 2.2. The bonus will only be applied to the first 200 clients that are eligible during the promotion period.
- 2.3. To be eligible for the Deposit Bonus, participants must:
 - 2.3.1. Register after the start date of the promotion
 - 2.3.2. Verify the account (Finish KYC process)
 - 2.3.3. Make the first deposit
- 2.4. Bonus Calculation:
 - 2.4.1. Clients will receive a 100% bonus on their deposit for amounts up to 50 USD during the Promotion Period.
 - 2.4.2. For deposits exceeding 50 USD, clients will be entitled to a fixed bonus of 50 USD.
 - 2.4.3. Check the below table for better understanding of the bonus amount:

First Deposit Amount	Bonus
<= 50 usd	100% of the deposit amount
> 50 usd	50 usd

- 2.5. Upon successful deposit, client will receive up to \$50 credit bonus in their account:
 - 2.5.1. The bonus can only be redeemed once per client
 - 2.5.2. The amount is not withdrawable
 - 2.5.3. Participants may use the credit bonus to trade various financial instruments available on the platform.
 - 2.5.4. Profits can only be withdrawn when clients meet the Trading Requirement:
 - 2.5.4.1. The total minimum of 2 standard lots in trading volume

- 2.5.4.2. Orders opened and closed within 2 minute, and hedge orders will be excluded from the promotion.
- 2.5.5. Withdrawal requests can be made at any time during the promotion and will be processed in accordance with our standard withdrawal procedures.
- 2.6. All account types are eligible for this promotion.
- 2.7. All products except Stocks will be accepted for the minimum trading requirement.
