

MyTrazé Event 100% Deposit Bonus

Terms and Conditions

1. Eligibility

- 1.1. The Deposit Bonus Promotion is a limited time offer for the participants of the MyTrazé Event.
- 1.2. This promotion is available for a limited time only and is subject to termination at the discretion of the company.
- 1.3. Participants must be of legal age (18 years or older) and have the legal capacity to register and participate in the promotion.
- 1.4. This offer is only for the actual participants taking part in the Learn & Earn promotion.
- 1.5. The offer is only for new clients.

2. Mechanism

- 2.1. To be eligible for the Deposit Bonus, participants must:
 - 2.1.1. Have registered account with Trazé
 - 2.1.2. Verify the account (Finish KYC process)
 - 2.1.3. Make the first deposit
 - 2.1.4. All the bonuses will be added to clients account within 24 to 48 hours depending on time of deposit.
- 2.2. Bonus Calculation:
 - 2.2.1. Clients will receive a 100% bonus on their first deposit for amounts up to 50 USD during the Promotion Period.
 - 2.2.2. For first deposits exceeding 50 USD, clients will be entitled to a fixed bonus of 50 USD.

First Deposit Amount	Bonus
<= 50 usd	100% of the deposit amount
> 50 usd	50 usd

- 2.3. Upon successful deposit, client will receive up to \$50 credit bonus in their account:
 - 2.3.1. The bonus can only be redeemed once per client
 - 2.3.2. The amount is not withdrawable
 - 2.3.3. Participants may use the credit bonus to trade various financial instruments available on the platform.
 - 2.3.4. Profits can only be withdrawn when clients meet the Trading Requirement:
 - 2.3.4.1. The total minimum of 2 standard lots in trading volume

- 2.3.4.2. Orders opened and closed within 2 minute, and hedge orders will be excluded from the promotion.
- 2.3.5. Withdrawal requests can be made at any time during the promotion and will be processed in accordance with our standard withdrawal procedures.
- 2.4. All account types are eligible for this promotion.
- 2.5. All products except Stocks will be accepted for the minimum trading requirement.
